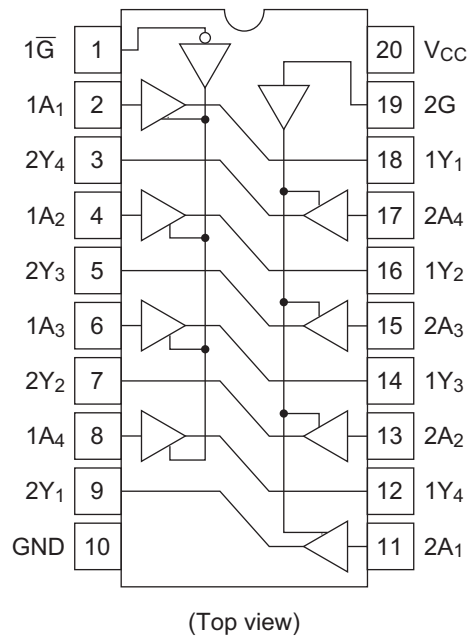

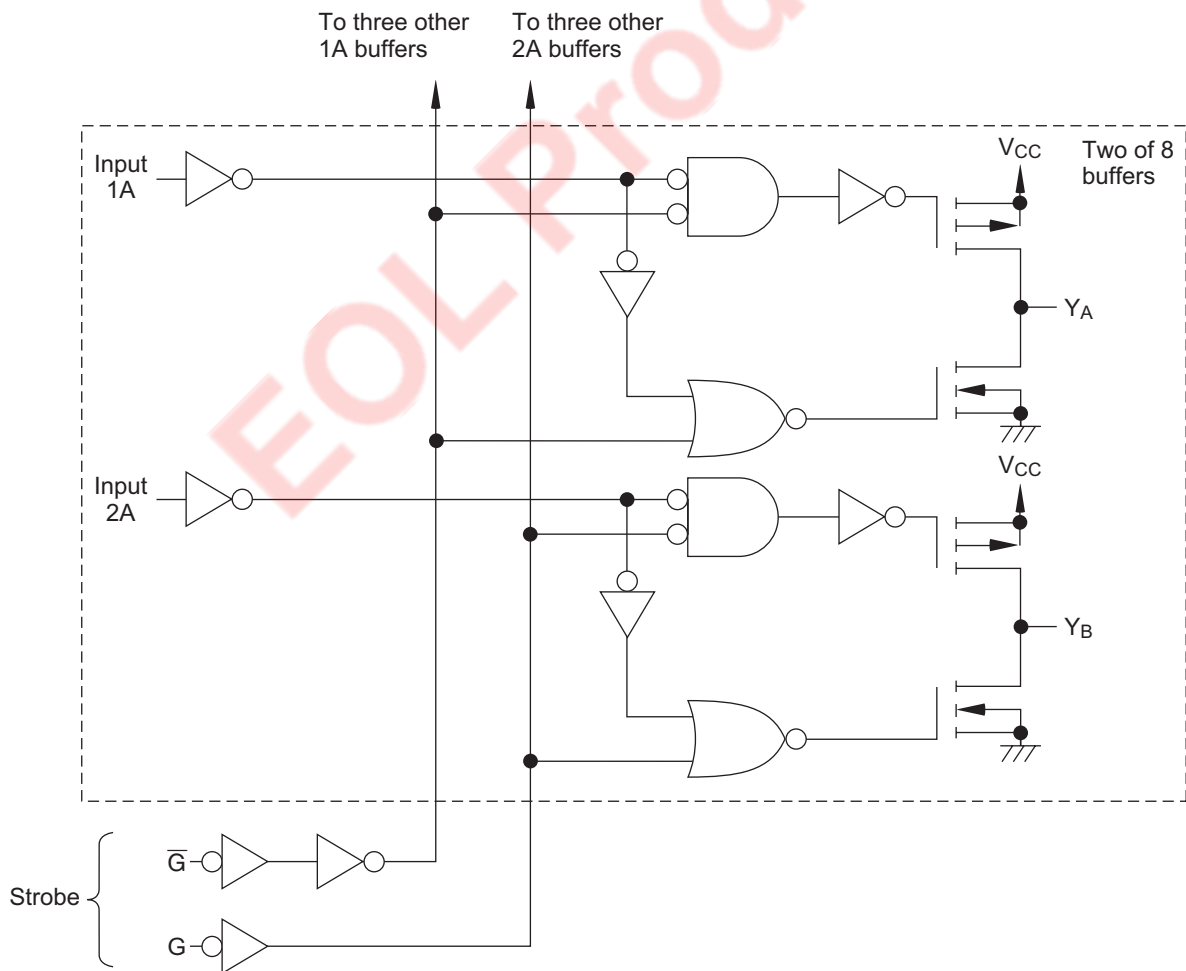

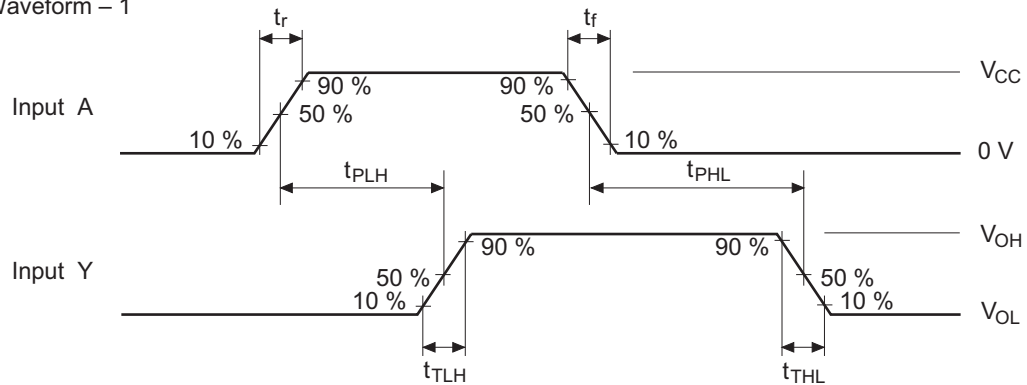

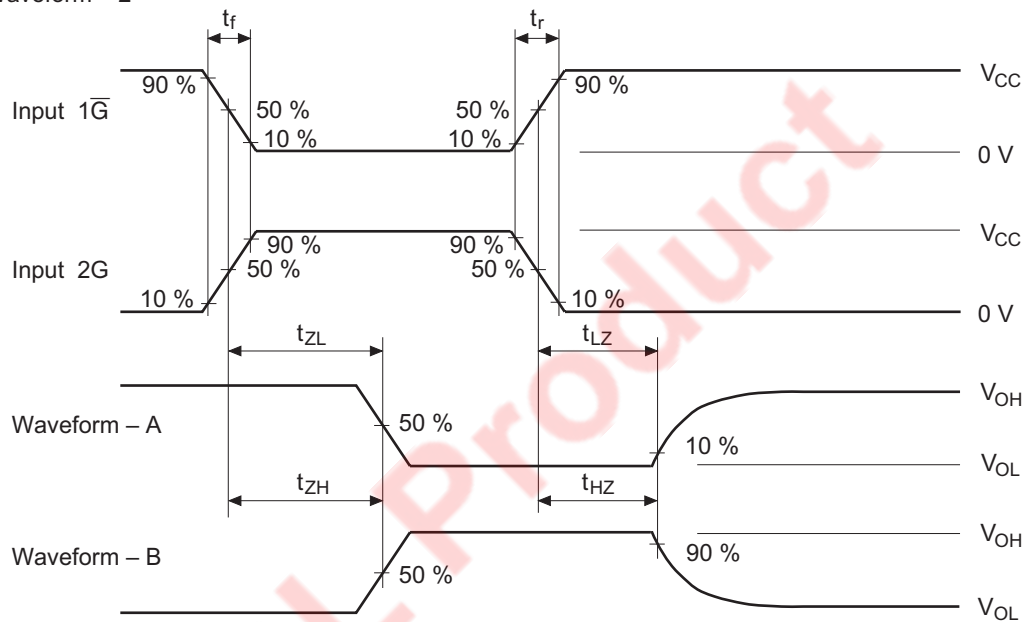

• Waveform – 1

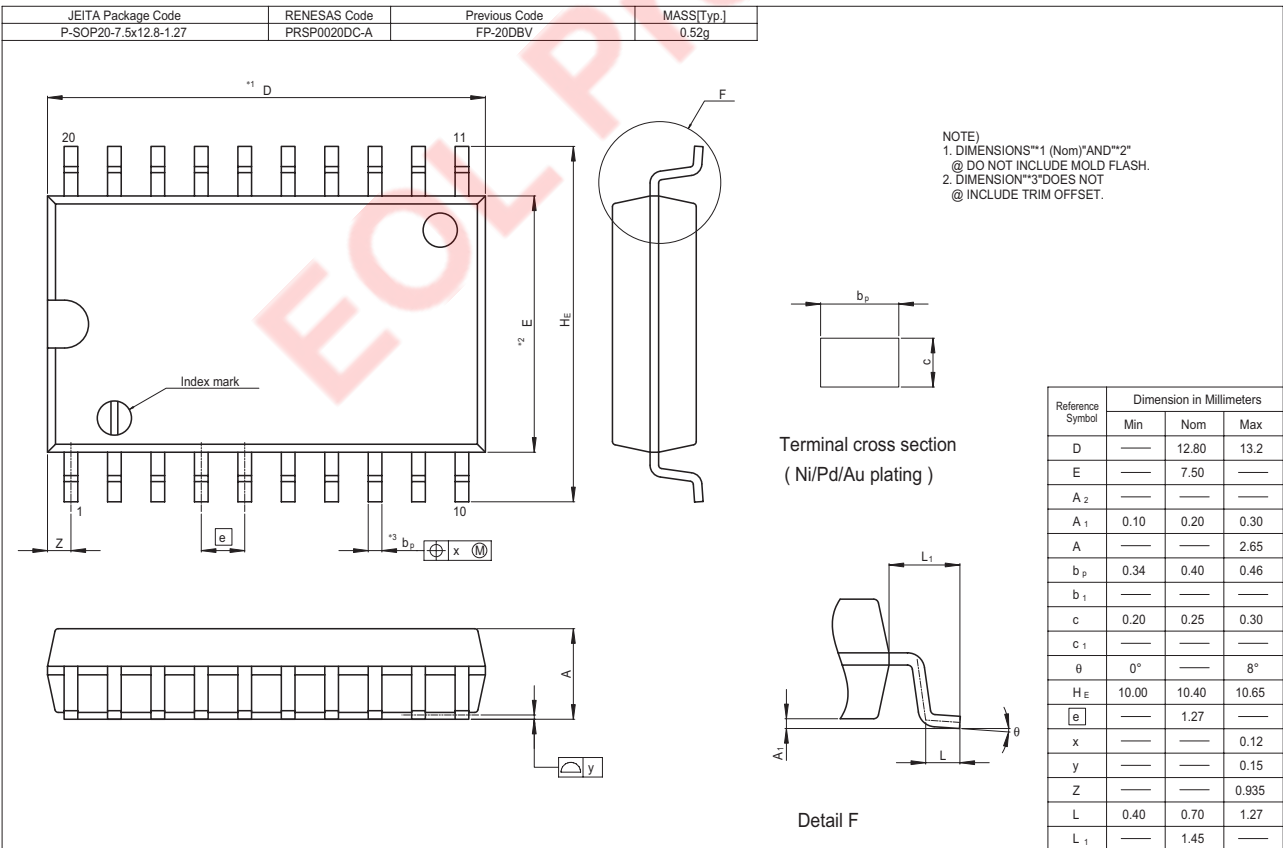
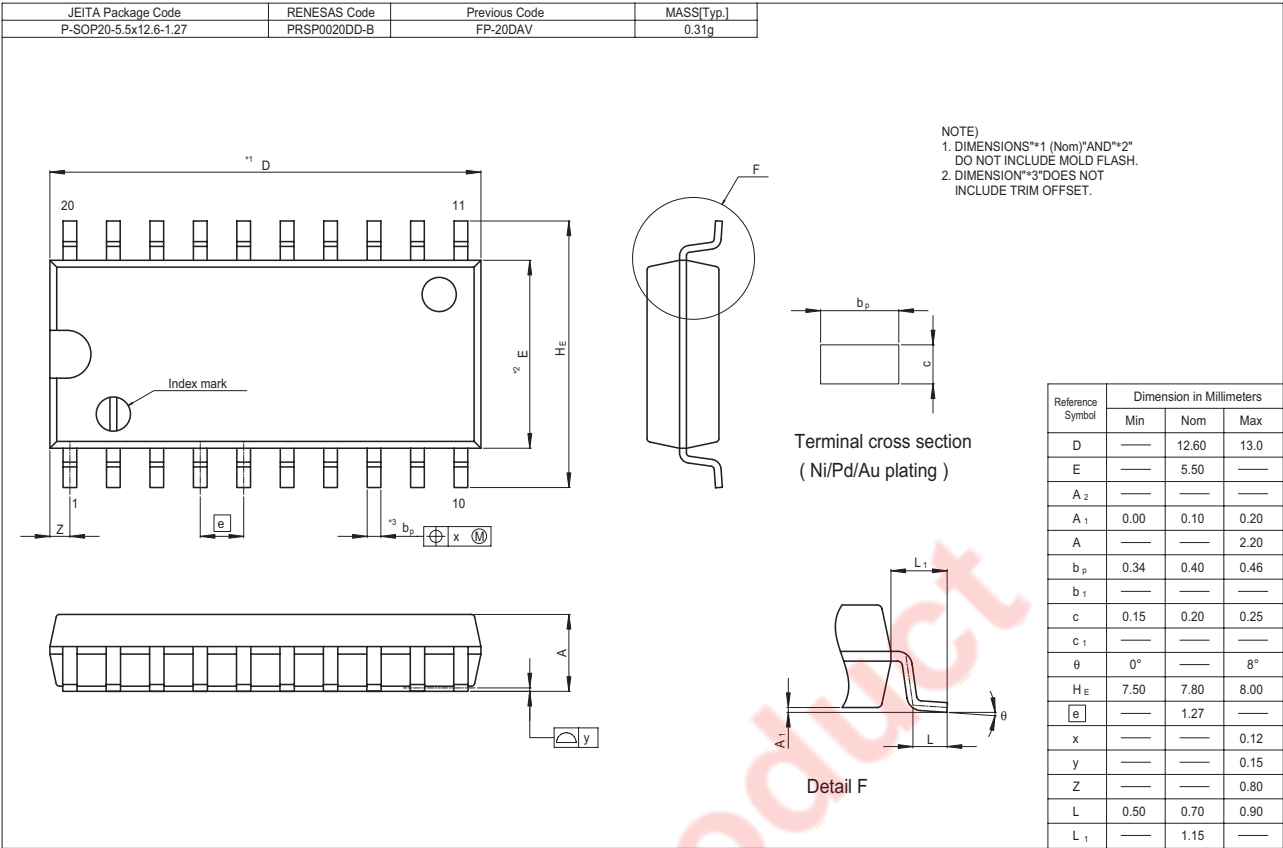
