

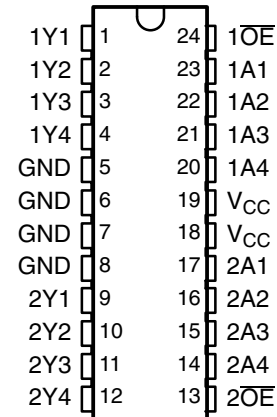

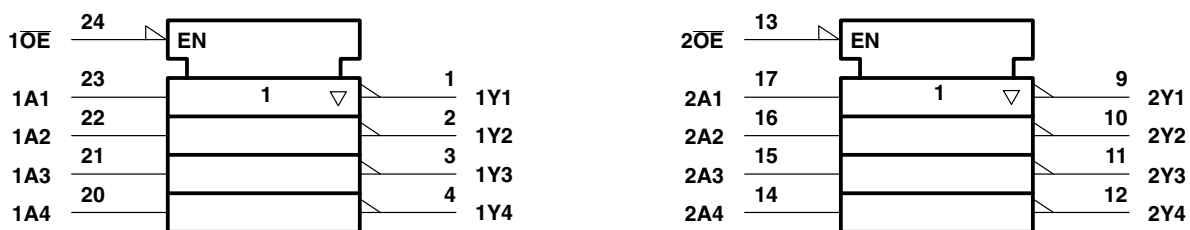

This device provides inverting outputs and symmetrical active-low output-enable ($\overline{OE}$) inputs. This device features high fan-out and improved fan-in.

The 74ACT11240 is characterized for operation from -40°C to 85°C .

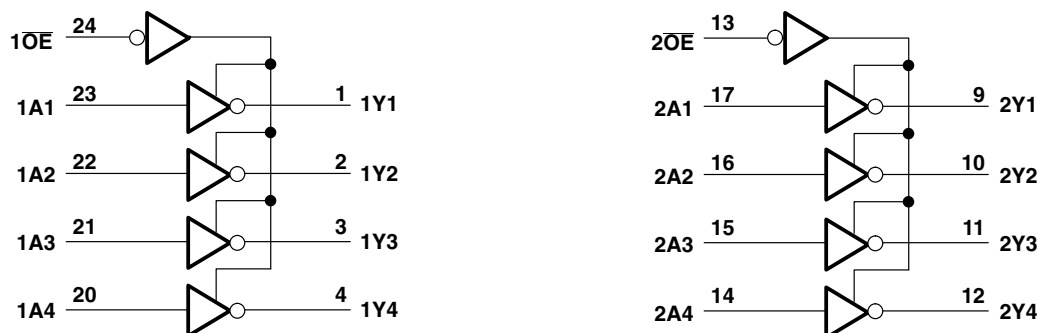

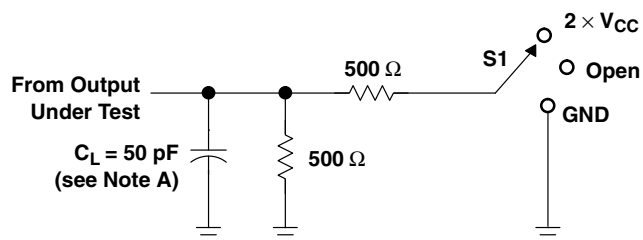

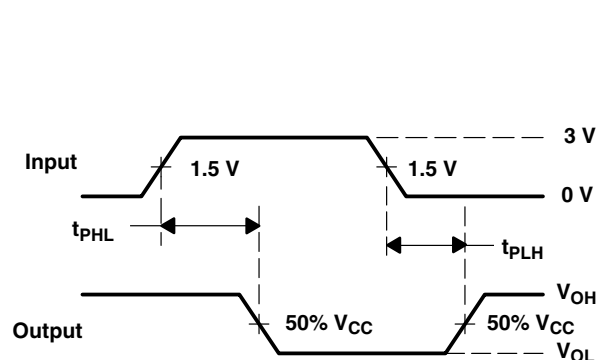

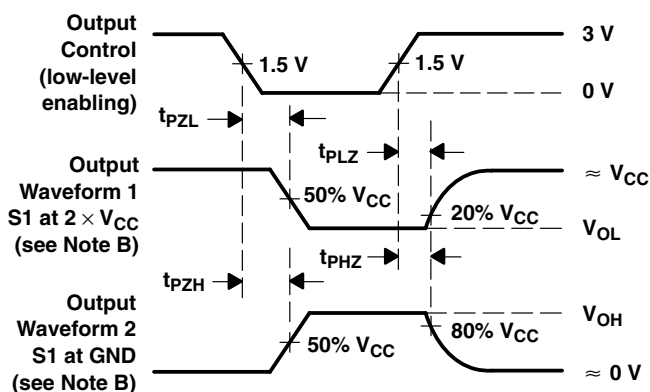

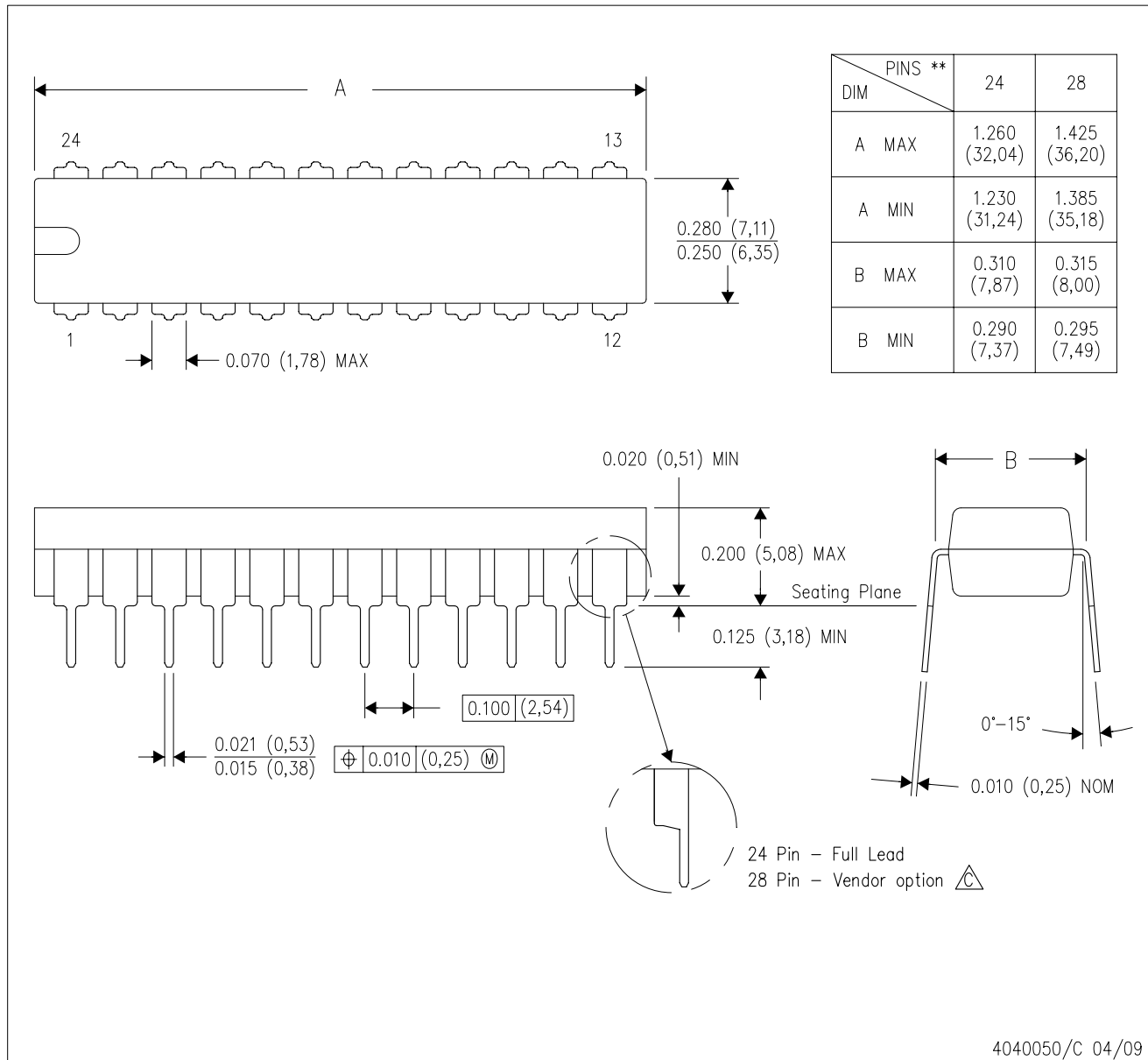

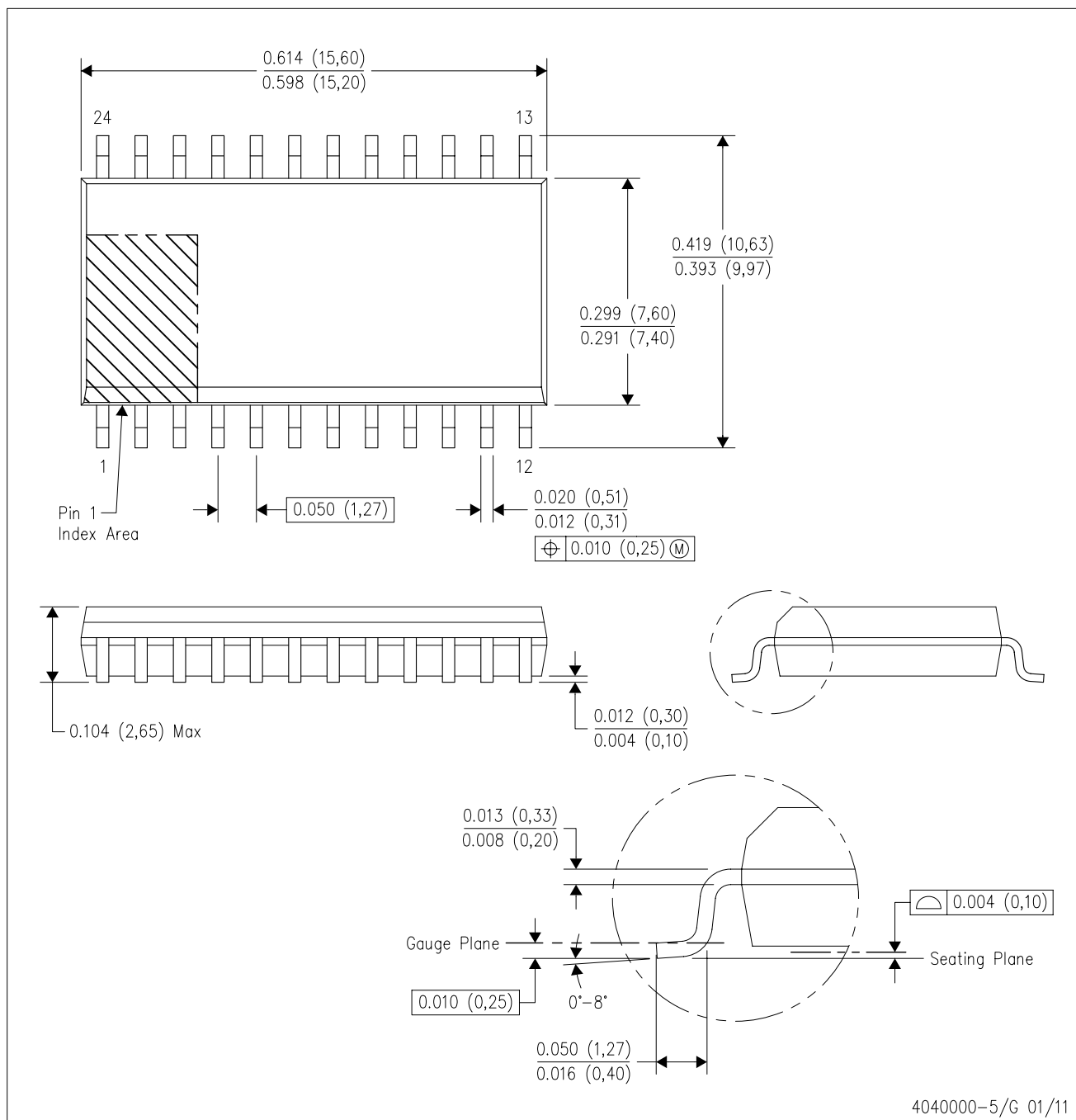
PLASTIC DUAL-IN-LINE PACKAGE

PLASTIC SMALL OUTLINE

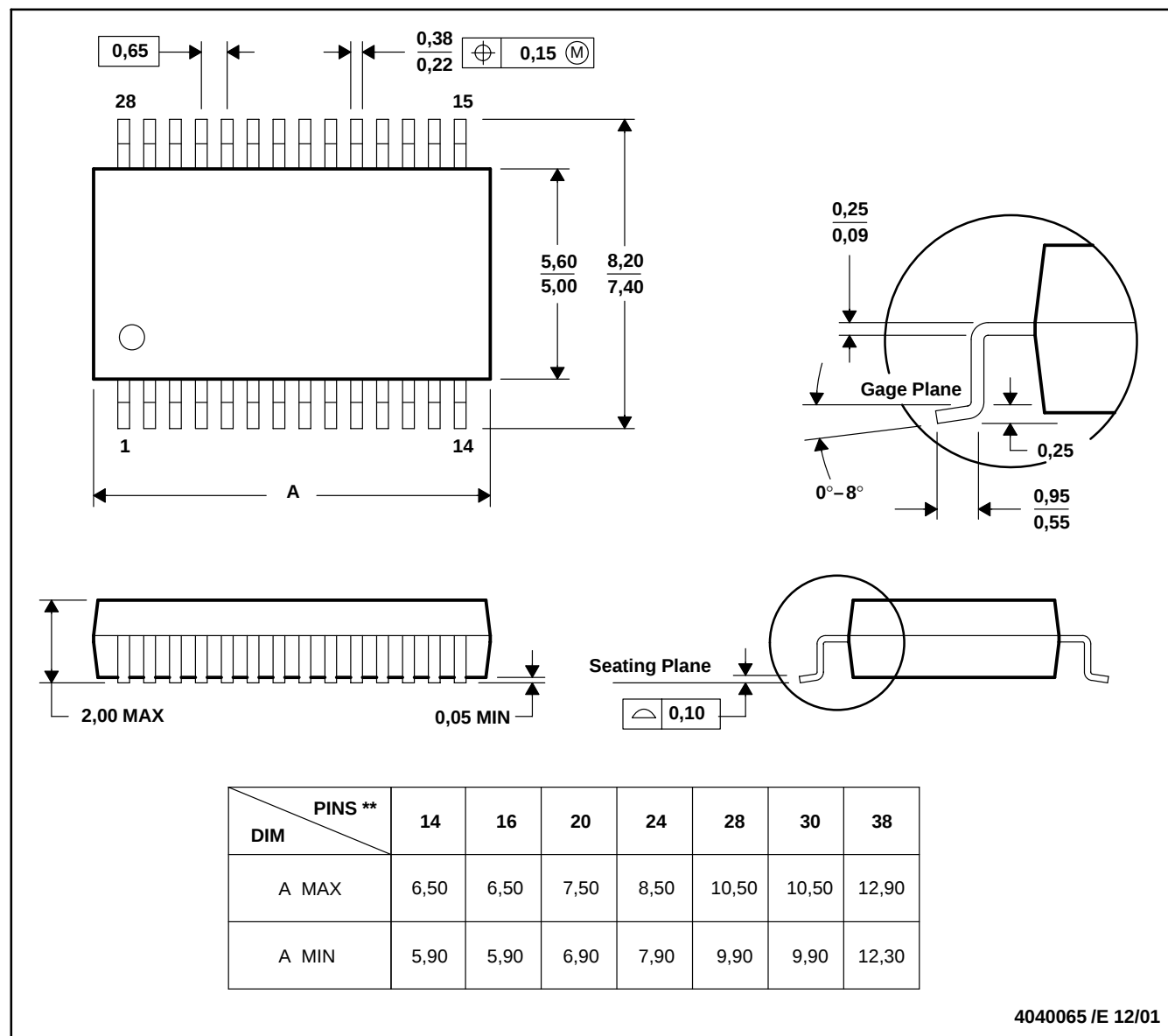
