# 1 Product Overview

HDCVI distributor is mainly used to connect front-end and rear-end devices for long distance transmission without data loss. Meantime, it separates 1-ch HDCVI HD video into three channels.

## 1.1 Features

- Support 1-ch HDCVI HD video output to three channels
- Lossless non-compression transmission.
- Support DC 12V power.
- Port: BNC.
- Appearance dimension: metal plate or section, brand new appearance and structure.
- Working temperature:  $-10^{\circ}\text{C} \sim 55^{\circ}\text{C}$ , max consumption 5W.
- HDCVI data input is normal or not, power indicator and data transmission indicator.

The typical application of HDCVI distributor is shown in Figure 1- 1



### 2.1 Port

#### Front Panel




Figure 2- 1 TP2600

The front panel is shown in Figure 2- 1.

Indicator	Note	Color	Device Status
PWR	Power status indicator	Green	Means power connection is normal
VIDEO	BNC video output indicator	Green	Means video input is normal
DATA	RS485 data transmission indicator	Green light flashes	Means transmitting data

Port Name	Note
IN	1-ch HDCVI video input. Port type: BNC port.
DC 12V	Power port, connect to DC12V power.

#### Rear Panel





Figure 2- 2 TP2600

The rear panel is shown in Figure 2- 2.

1-ch HDCVI HD video is inputted from IN port, and output into three channels (OUT1, OUT2, OUT3).
