Product data sheet

1. General description

The 74LV07AT is a hex buffer with open-drain outputs. The outputs are open-drain and can be connected to other open-drain outputs to implement active-LOW wired-OR or active-HIGH wired-AND functions.

Designed to operate over a V_{CC} range from 4.5 V to 5.5 V, the inputs are TTL compatible, which allows the device to be used to translate from 3.3 V to 5 V.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial Power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

- Supply voltage range from 4.5 V to 5.5 V
- Typical t_{PZL} of 3.5 ns at 5 V

- Supports mixed-mode voltage operation on all ports
- I_{OFF} circuitry provides partial Power-down mode operation
- Latch-up performance exceeds 250 mA per JESD 78 Class II
- ESD protection:
 - ◆ HBM ANSI/ESDA/JEDEC JS-001 Class 2 exceeds 3 kV
 - ◆ MM JESD22-A115-A exceeds 150 V
 - ◆ CDM JESD22-C101E exceeds 2 kV
- Specified from -40 °C to $+85$ °C and from -40 °C to $+125$ °C

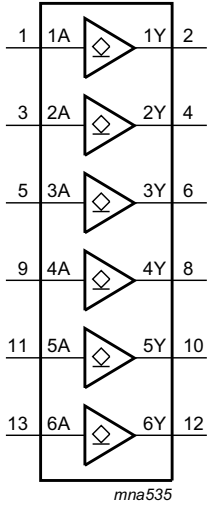


Fig 1. Logic symbol

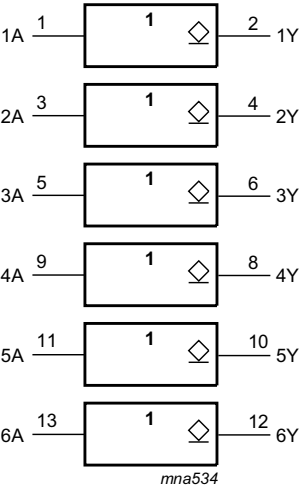


Fig 2. IEC logic symbol

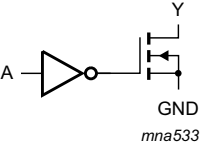


Fig 3. Logic diagram for one gate

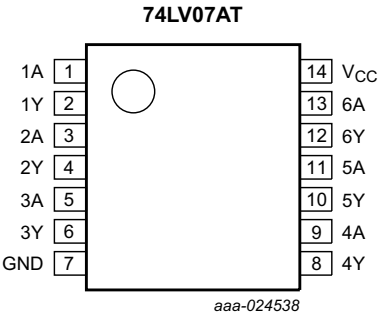


Fig 4. Pin configuration TSSOP14

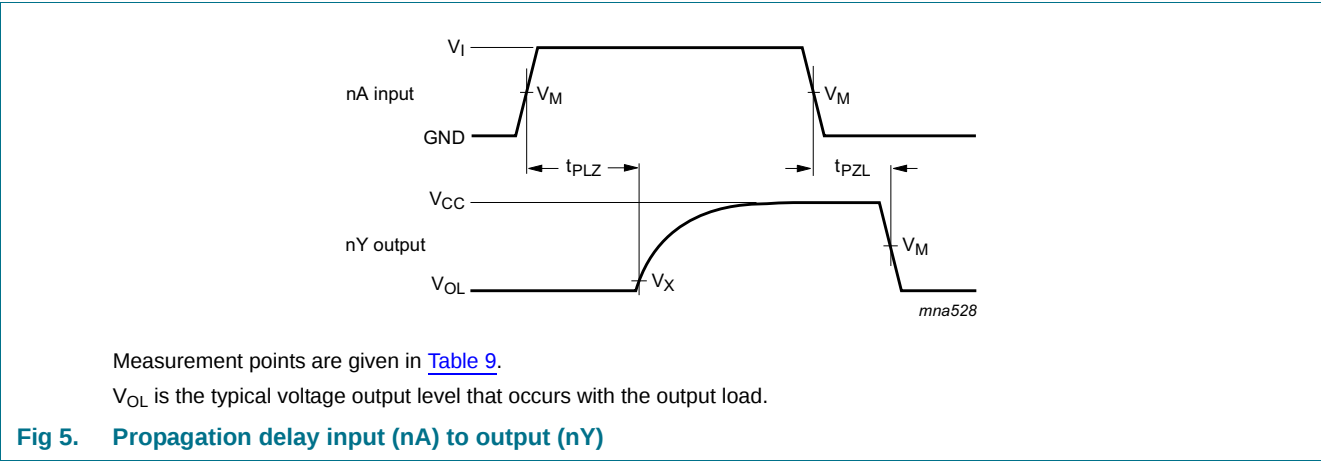

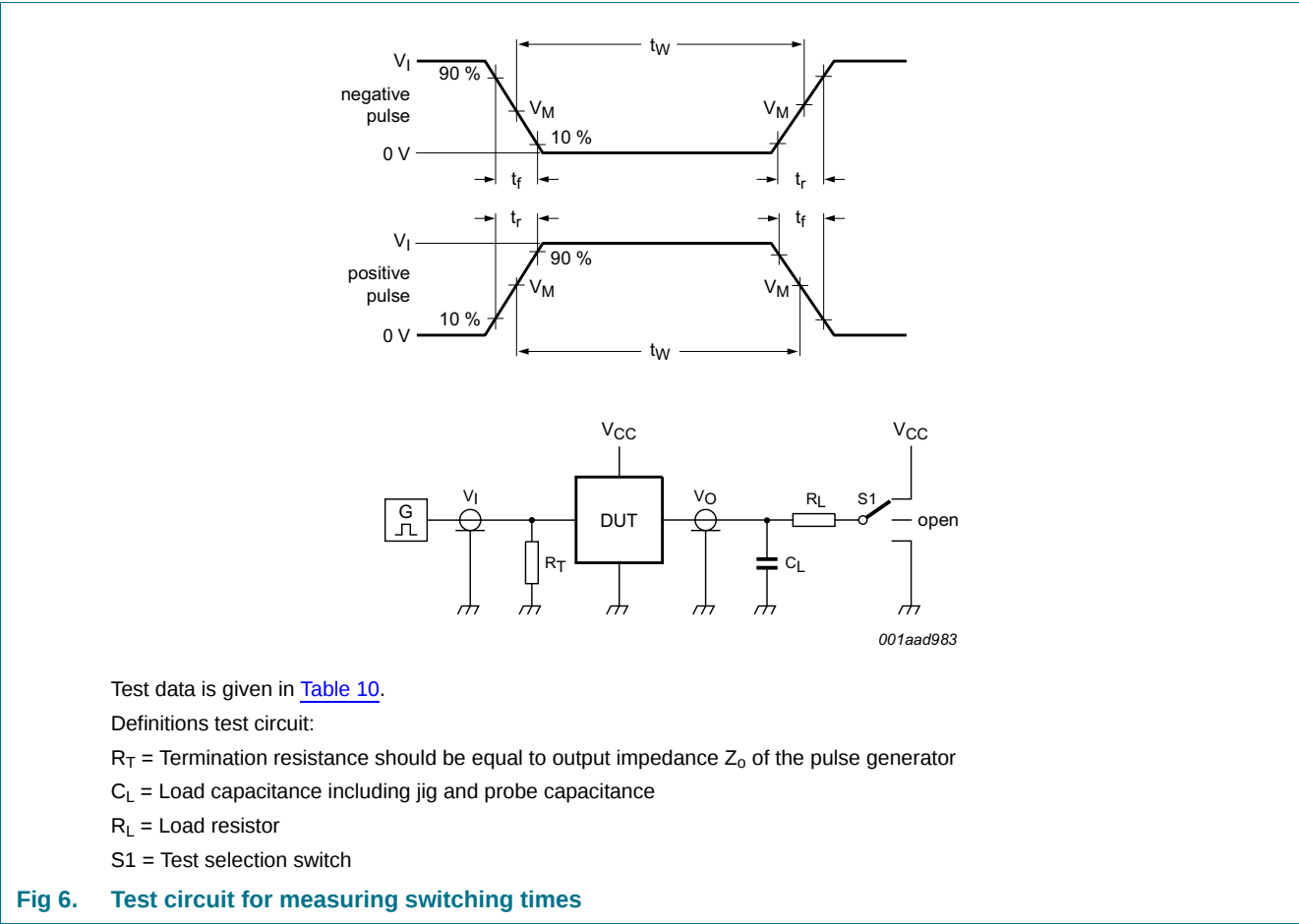

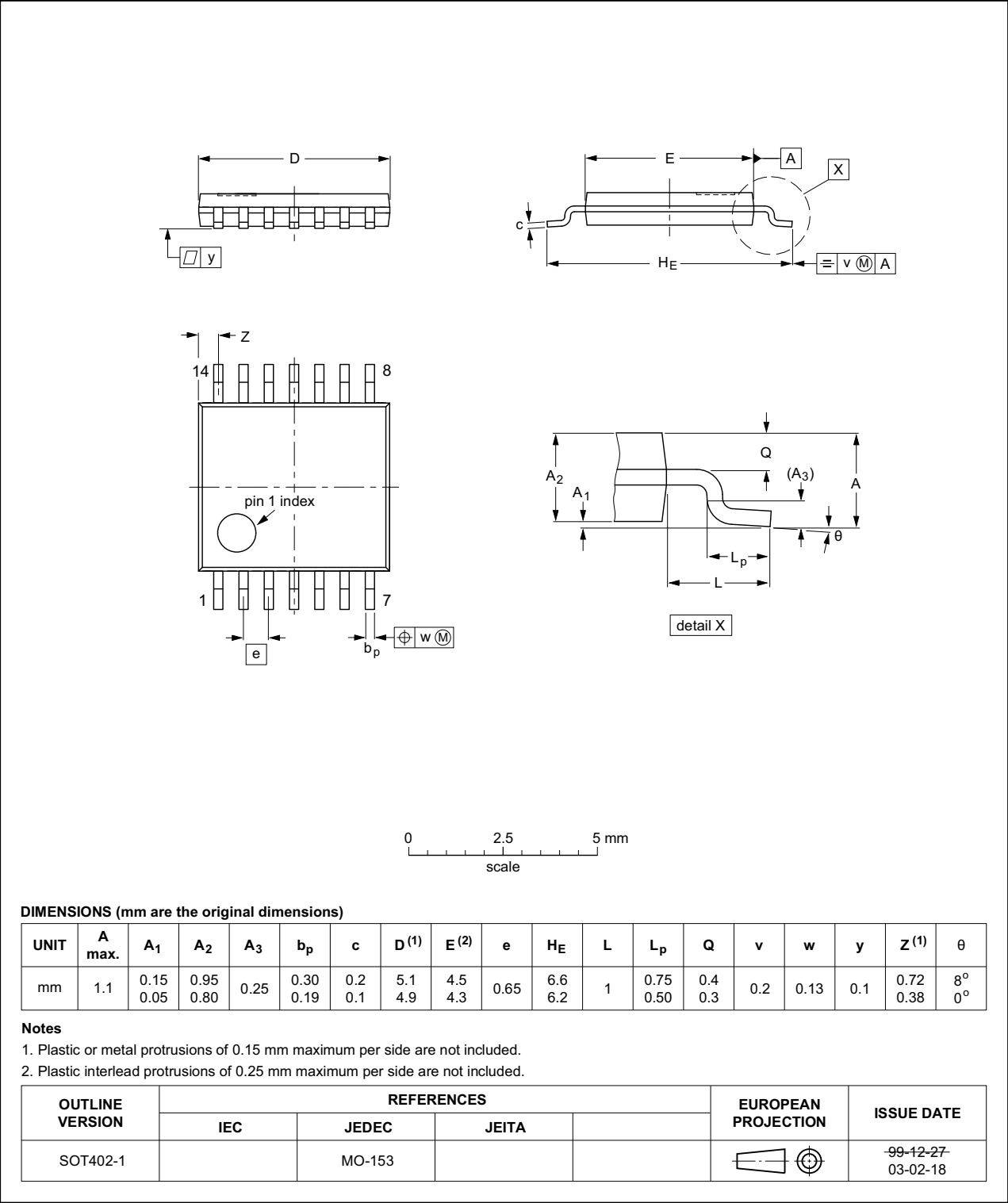


Fig 7. Package outline SOT402-1 (TSSOP14)
